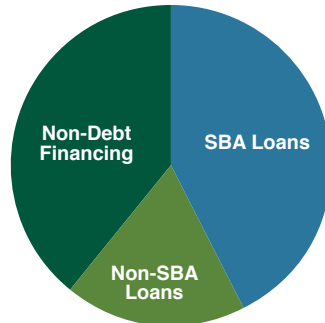

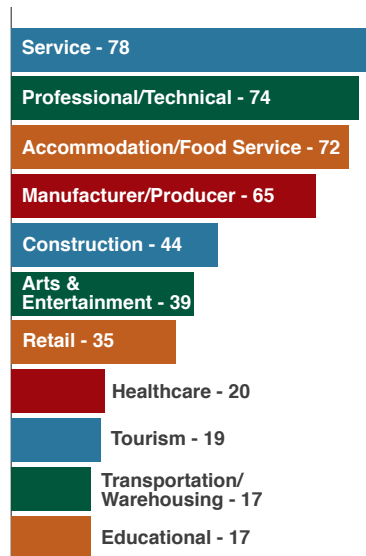

## Services

Across the state, there has been an uptick in the number of small business owners and entrepreneurs seeking assistance from Alaska SBDC. In fact, the total number of clients we assisted this quarter increased by 27% over last quarter and more than 50% over the second quarter of FY2017.

Of the diverse range of industries served by Alaska SBDC, it is particularly interesting to note an increase in the number of manufacturer/producer clients we are seeing. Alaska is not traditionally considered a manufacturing state, so an upward trend of this nature is both surprising and worth watching.

## New Clients

The Alaska SBDC onboarded a total of 243 new clients during the second quarter of FY2018. This represents a 25% increase over the first quarter of the fiscal year and more than double the second quarter of FY2017.

## Workshops & Community Outreach

More than 717 people attended Alaska SBDC workshops around the state. These workshops were offered in both in-person and online formats, and subjects included: Starting a Business; Business Plan; Employee vs. Independent Contractor; Legal Aspects: LLC; Profit Mastery; Quickbooks; and more.
